- Property that is rundown, call 311
- Yard waste needs to be put out at the appropriate time. (the day before your pickup)
- Be aware of the code enforcements so that you are not fined.
- Bulk items, you have to schedule a bulk pick up
- A house has to be up to minimum code in Charlotte
- How long can you keep a blue tarp over your house? 60 days to fix something. If not fixed, then they'll get fines on top of fines. No normal amount of time if someone doesn't have the money to fix.

Safety Tips and Crime Discussion:

- 1. Helicopter has been asked to do a zone check. We have officers on bikes, and also if officers are not on a call they have been asked to patrol the area.
- 2. If you see something...SAY SOMETHING.
- 3. Profiling: if you believe in your heart that person is suspicious...then call. Police do not care what color they are.
- 4. What is Suspicious Activity: People walking up and down the street looking towards houses, acting different, just doesn't belong, Backpacks and on foot, hoodie and gloves, etc.
- 5. Call 911 not 311. Calls are triaged. Call...don't wait. When you call 311, that call goes to 911 which is not fast enough. Then call your neighbors fi you see something as well.
- 6. We have to work together as a neighborhood.
- 7. It's ok to say "I think the person is casing this house, I think this car/person does not live here but is acting suspicious"
- 8. This is a transitioning neighborhood so there is a lot going on.
- 9. Text your neighbors, communicate neighbors when if you are leaving.
- 10. Where do the cops canvas? They canvas Madison Park when they are not on a call or working a response area. It's 1 or 2 officers. Officers are trying to "minority report" it to figure out where the next one might happen.
- 11. If you are going out of town, you can contact Officer Mohammed and he or someone will check on your house.
- 12. Thieves who rob on foot vs car:
 - a. On foot backpacks, hoodie, gloves...they'll take the small stuff.
 - b. In a Car thieves will rent vans and circle back and just circle around. Most likely a crew and they'll take the big stuff. Stuff they can't carry and need a car/van. Look for suspicious cars and vans parked on streets.
- 13. Don't follow the suspicious persons. Just call 911
- 14. Buy a safe and put all firearms in that safe and lock it.
- 15. Homework: Bring someone with you to the next HOA meeting who has never been to one of these meetings.
- 16. If you can afford a security system. Also turn your lights on at night if you are gone.
- 17. Close your blinds, turn on radios and TVs. It's called "Target Hardening"...make it hard for them to figure out if you are home or not!
- 18. If you see panhandling on the median, call 911. It's illegal.
- 19. Please watch your comments on Facebook and on NextDoor. Comments hurt people.
- 20. Don't post your vacation plans on social media!! Don't check-in on Yelp, or on Facebook letting people know where you are.
- 21. If you have teenagers that are going to be home, just make sure they are aware of the issues and know where they are as a precaution
- 22. Lock your wifi password! No free internet
